- i&i Prague s.r.o., with its registered office at Flemingovo náměstí 542/2, Dejvice, 160 00 Prague 6, ID No.: 06058485, registered in the public register kept by the Municipal Court in Prague section C, insert 275316 (hereinafter referred to as "Controller" or "i&i Prague"), collects your personal data in accordance with the following terms and conditions.
- 3. **Controller and processor** have the meaning within the meaning of Regulation (EU) No. 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (hereinafter referred to as "GDPR").

## Principles of processing:

- 4. The Processor adheres to the following personal data processing principles:
  - a) lawfulness, fairness and transparency in relation to the data subject,
  - b) all data are collected for specified, explicit and legitimate purposes set forth below;
  - c) the processor only processes data that is adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed;
  - d) all data are accurate and, where necessary, kept up to date;
  - e) the data are processed and stored only for the time necessary;
  - f) the processor processes the data in a manner that ensures appropriate security of the personal data.

## Scope of processing of your personal data:

- 5. The Processor will process your personal data to the extent that you have provided it in connection with Prague.Bio Conference and will transmit them to i&i Prague as Controller in accordance with the terms of registration. The Processor will especially process:

  - the identification data about all members of the project authors, inventors, founders,
  - logo of the project
  - electronic or written communication with the data subject.

## How the Processor obtains personal information:

- 6. Legal basis for collecting and processing your personal information are stated in part 3 of our Privacy Policy, which can be found on our website.
- 7. The Processor obtains personal data directly from the data subject during registration,
- 8. The Processor will process your personal data in connection with the purpose for a period of 2 years after you have given your consent to the Processor.
